### CORRIGENDUM

The name of the institution "Regional College of Education, Kauli, Chandigarh-Rajpura Road, Distt- Patiala, Punjab" was recognised for conducting B.Ed. Programme with an intake of 100 students vide order no. F/NRC/NCTE/F-3/PB-219/2568 dated 17.06.2005. Thereafter, change in the name of the institution was allowed as SAINT KABIR COLLEGE OF EDUCATION as per the decision taken in 118th (2nd sitting) meeting held on 23rd -25th June 2007 on request of the institution.

- Accordingly, a revised order was issued to the institution allowing the change of name 2. of the institution from "Regional College of Education, Kauli, Chandigarh-Rajpura Road, Distt- Patiala, Punjab" to Saint Kabir College of Education, Kauli, Chandigarh, Rajpura Road, Distt.- Patiala. Punjab vide NCTE order No. F.NRC/NCTE/F-3/PB-219/22515 dated 25.07.2007.
- Subsequently, a Revised recognition order was issued to the institution in terms of NCTE (Recognition Norms and Procedure) Regulations. 2014 vide order No. F.No.NRC/NCTE/PB-219/2015/109030-34 dated 31.05.20215. However, this order was issued in favour of the old name i.e. Regional College of Education instead of Saint Kabir er to be welferdy College of Education.
- On account of the above, the name of the institution "Regional College of Education, 4. Kauli, Chandigarh, Rajpura Road, Distt. - Patiala, Punjab mentioned in the Revised Recognition Order no. F.No. NRC/NCTE/PB-219/2015/109030-34 dated 31.05.2015 issued by NRC. NCTE may be read as "Saint Kabir College of Education Kauli. Chandigarh-Rajpura Road, Distt-Patiala, Punjab.
- The other contents mentioned in the Revised Recognition Order no. F.No.NRC/NCTE/PB-219/2015/109030-34 dated 31.05.2015 shall remain unchanged.
